A few days ago Cheri Fritts called me from Missouri. She told me of her passionate concern for what is happening as I write to wild horses and burros in the USA. She has developed a prayer. We prayed that prayer as a congregation this past Sunday. Before we did, I gave my own opinion as to why this has importance.

We are being de-sensitized to violence and abuse of the weak and oppressed. Having dominion does not mean domination to do whatever we want as if animals have no souls. Dominion means to tend, to nurture, to care for, to protect, to govern properly as shepherd-leaders, to take up the cause of those God has placed in our care. As violence towards animals increases with the breaking of moral boundaries, so also we see those boundaries broken relative to the life of the unborn, to children, to the elderly, etc. People are becoming numb to the sale of body parts, even joking on T.V. about what one would do with the money they might get from selling one of their kidneys. It isn't funny. All life matters.

Cheri wrote a prayer and asks that you join her in appealing to our Heavenly Father for divine intervention on behalf of the wild horse and burro population in the U. S. A.

"Whoever is righteous has regard for the life of his animal, but the mercy of the wicked is cruel." Luke 12:6 "Are not five sparrows sold for two pennies? Yet not one of them is forgotten by God." Proverbs 12:10

Cheri Fritts has been a horsewoman from her youth, and also a horse artist. WhiteHorseArts.com She wrote me:

"In the late 1960's the wild horses had been persecuted and slaughtered almost to the point of extinction. There was a nationwide public outcry and Congress passed The Wild Free-Roaming Horses and Burro Act of 1971. The Act said the Horses and Burros are "living symbols of the historic and pioneer spirit of the West, which continue to contribute to the diversity of life forms within the Nation and enrich the lives of the American people." The Act made it a Federal crime to harm or remove horses from the public lands, and the Bureau of Land Management (BLM) under the Department of Interior was charged with managing the horses on their existing ranges.

Since 1971 the Act has been amended and its original language has changed. Now there are loopholes that allow the BLM, the agency supposed to be protecting these animals, to drastically reduce their numbers and even to sell them to for slaughter.

Over 80% of the grazing rights on Public Land have been given to the livestock industry. Livestock interests wants the horses gone so they can bring yet more livestock onto the public land where the horses, burros and wildlife live. The livestock is destroying the natural habitat and the wild horses and burros are being blamed and "scapegoated" The horses are being removed at an alarming rate from Public Land. The BLM can and will sell the horses for

slaughter or destroy them. They have "zeroed out" several herds all over the Western states in the last few weeks."
